- We further agree that we will cooperate and discipline our child in the home as needed.
- We agree that if any problem should arise concerning our child, we will, in the love of Christ and with prayer, register necessary concerns with the teacher or administrator.
- We understand that assessments will be made to cover damage to school property, including breakage of windows, abuse of equipment, etc.
- We know of no permanent physical disability that would prohibit the applicant's participation in physical education classes. If a physical problem exists, please attach a note of explanation. We understand that our child is required to have a physical examination prior to school entrance and that this examination will be within 12 months of the application.
- We give permission for our child to take part in all school activities including sports and school sponsored trips away from the school premises and absolve Webster Christian School from any liability of injuries to our child due to these activities.

- We agree to pay the tuition according to arrangements that shall be made and to make all required payments in a timely fashion. We understand that report cards and transcripts will not be released until our account is paid in full.
- We agree to be responsible for a minimum of three months of tuition costs (based on ten payments per school year) for any withdrawal of a student after enrollment has been guaranteed. I further understand that this amount is a non-refundable tuition fee.

Doctrinal Statement of

WEBSTER BIBLE CHURCH & CHRISTIAN SCHOOL

1. **Doctrine of the Scriptures:**

We believe in the plenary verbal inspiration of the Bible, both Old and New Testament, fully inerrant in the original autographs as the Word of God, and that it is the supreme and only authority in all matters of faith and conduct. (*II Peter 1:21; II Timothy 3:16-17*)

2. **Doctrine of the Trinity:**

We believe that God subsists in three persons - Father, Son, and Holy Spirit. These three are one God, the same in substance, equal in power and glory. (*Matt 3:16-17; Matt 28:19; II Cor 13:14; John 10:30; Acts 5:3-4*)

3. **Doctrine of Christ:**

We believe in Jesus Christ, God's only begotten Son, conceived of the Holy Spirit, born of the virgin Mary, sinless in His life, true God and true man. (*Isa 7:14; Matt 1:18-23; II Cor 5:21; Col 2:9; Phil 2:5-8*) We believe that He died for our sins according to the scriptures and that He was buried and that He rose again the third day bodily. (*I Cor 15:3-4; Luke 24:39*) We believe in His ascension into Heaven, His high priestly intercession for His people and His personal, imminent, pre-tribulational return to rapture His church. We further believe in His visible, premillennial, return to the world according to his promise. (*Acts 1:11; Heb 7:25; I John 2:1; I Thess 1:10; I Thess 4:13-14; I Thess 5:1-11; Matt 24:24-29; Jude 14; Rev 19:11-21*)

4. **Doctrine of the Holy Spirit:**

We believe that the Holy Spirit seals, baptizes, indwells, and regenerates the believing sinner at the moment of conversion. We believe He sovereignly gives every Christian at least one spiritual gift for service, but that certain gifts such as apostleship, prophecy, tongues, interpretation of tongues, healing via touch, and miracles were temporary sign gifts and are no longer in the church today. (*I Cor 3:16, 12:11-13, 13:-8-10; 14:20-22; Eph 4:30; John 3:5; Heb 2:1-4*)

5. **Doctrine of Salvation:**

We believe that all men by nature and choice have sinned, but that God so loved the world that He gave His only begotten Son that whosoever believeth in Him should not perish, but have everlasting life. (*Isa 53:6; Rom 3:23; John 3:16*) We believe that those who receive by faith the Lord Jesus Christ as Savior are born again of the Holy Spirit and thereby become children of God. Whereas those who refuse to accept Christ as Lord and Savior will be forever separated from God in Hell. (*John 3:3, 36; II Cor 5:17; Rom 8:9; John 14:16-17; Matt 25:46*)

6. **Doctrine of the Church:**

We believe in the church, the universal body of Christ, composed of believing Jews and Gentiles. We believe in the establishment and continuance of local churches, composed only of born-again believers who have been baptized by immersion. (*Acts 2:41, Acts 8:12, Acts 8:36-38, Acts 10:48, Acts 14:27, Acts 18:8, Acts 20:17, Acts 20:28-32; Eph 2:12-16*) We believe that to the local church is committed for observance, "till He comes" the ordinances of baptism and the Lord's supper and the task of persuading a lost world to accept Jesus Christ as Savior and to enthrone Him as Lord and Master. (*Matt 28:19-20 ; I Peter 3:15 ; I Cor 23-26*)

7. **Separation of Church and State:**

We believe that each church is independent and autonomous and must be free from interference by any ecclesiastical or political authority. Church and state must be kept separate as having different functions, each one fulfilling its duties free from the dictation or patronage of the other. (*Acts 5:29; Acts 15:14; Matt 22:21*)

8. **Church Leadership:**

A. We believe that men are to be pastors, elders, deacons, and in leadership positions of the church. Women are not called by God to be pastors, elders, deacons, or church leaders. Women may act as teachers of children, youth and women, as leaders of specific women's ministries. They may not serve as Sunday School Superintendent or Webster Christian School Administrator. (*I Cor 14:34; I Tim 2:11-12; I Tim 3:1-12; Titus 1:5-9; Titus 2:3-5*)

B. We believe that homosexuality is a sin of the basest sort and we will not permit a homosexual to be a member of the church, to hold any office or to teach in any capacity to anyone. (*Gen 19:1-4; Rom 1:24-32; I Cor 6:9-11*)

9. **Christian Living:**

We believe that all saved should, by precept and example, lead a life free from all questionable habits and indulgences and should try to live daily so that others may see Christ in them. We believe that the saved are under obligation to all the world by life and word to the truth and proclamation of the Gospel. (*Rom 12:1-2; II Cor 5:15-18; Acts 1:8; I Cor 5:11-13, I John 2:15-17; I Cor 6:19-20*)

10. **Doctrine of Resurrection:**

We believe in the bodily resurrection of the just and the unjust, the everlasting blessedness of the saved and the conscious everlasting punishment of the lost. (*John 5:28-29; Rev 20:4-5*)

11. **The Personality of Satan:**

We believe that Satan is a personal being, a fallen angel, prince of demons, the god of this age, the great enticer and deceiver, the adversary of Christ and His people, the accuser of the brethren whose end is in the lake of fire. (*Isa 14:12-15; Ezek 28:12-19; II Cor 4:3-4; I Pet 5:8; Rev 12:9-10; Matt 25:41; Rev 20:10*)

It should be understood that this Doctrinal Statement is not the sum total of all that we believe, but is a sufficient basis for like doctrine, like philosophy, loyalty and unity, and fellowship. We believe that all who sincerely accept it can and should work together "keeping the unity of the spirit in the bond of peace". (*Eph 4:3*)
